Regulation "Ennio De Giorgi" Prize

Foreword

To honour the memory of Ennio Giorgi

- the Mathematics and Physics Department of the Salento University
- the "Ennnio De Giorgi" Mathematics Research Centre of the Scuola Normale Superiore in Pisa
- the Mathematic Department of the Pisa University

set up a fund at Mathematics Italian Union (UMI) to create the Ennio De Giorgi Prize. These institutions hope for the increase of the Prize over the coming years, within the available resources, in order to ensure its four-year assignment in accordance with the modalities described in the following regulation.

In addition to the contribution of the promoters, the award fund budget can be increased through further sponsorships from individuals or institutions that wish to support this initiative.

At each assignment the amount of the prize will be established by the fund budget in order to ensure, if possible, that the award will remain constant over time.

Article 1

Starting from 2015 and every four years UMI shall assign, in connection with the annual meeting, the "Ennio Giorgi" Prize to a mathematician of Italian nationality who provided relevant contributions in the field of Mathematical Analysis and whose 46th birthday does not occur by 31th December of the year in which the prize is awarded.

Article 2

The prize is awarded by a panel consisting in 5 members appointed by UMI Scientific Commission, taking into account any proposals by funding Bodies.

Article 3

The Commission shall award the prize considering the scientific publications in the field of Mathematical Analysis printed in the four years preceding the award of the prize. Commission resolutions are unquestionable.

Article 4

Those eligible to the prize are all applicants who submit application form under article 5 and mathematicians nominated by UMI members, universities, research institutes and scientific academies, as set out in article 6.

Article 5

Applicants must send the application form to the UMI President within the call deadline. Applications must be sent by exclusively electronic means. To the applications shall be attached in PDF format the curriculum vitae, the publications printed in the four years preceding the award of the prize and a copy of an identity document proving nationality and date of birth.

Article 6

UMI members, Universities, Research institutes and Scientific academies may submit motivated nominations. Proposals shall be sent by exclusively electronic means to UMI President within the call deadline. To the applications shall be attached in PDF format the curriculum vitae of the nominated candidate and a list of his/her publications.

Article 7

The Prize will be awarded during the opening ceremony of the UMI annual meeting and it will be advertised on UMI website, where the name of the winner and those of the Commission members will be published. On these media will be published also the reason of the prize's award. The winner undertakes to held a conference at the Mathematics and Physics Department of the Salento University, a conference in Pisa and he/her assure to submit a summary of his/her more recent research. This essay will be published on 'Bollettino' of Mathematics Italian Union.

Article 8

The call announcement will be advertised on 'Notiziario' and on UMI website, as to ensure maximum dissemination of it and to exhort candidates nominations pursuant to article 6.

The expiry day for the submission of the applications and for the candidates nominations under article 6 will be at least 60 days after the date of the call announcement.
