

## PERSONAL DATA PROCESSING POLICY

#### Dear User,

Pursuant to Art. 13 of Regulation (EU) No. 679/2016, the Italian Mathematical Union invites you to read this policy describing the Data Processing Method used in the processing of your Personal Data.

Why are we asking You [to provide] Personal Data?

The [Personal] Data that you provide to us are required to manage your membership, to send you all the details relating to the organization of Congresses, Conferences, Seminars, Classes and other events organized by the [Italian Mathematical] Union, to issue receipts and process payments, to manage membership lists.

## Data Controller

The Data Controller of the [Personal] Data deriving from the use of the website is the Italian Mathematical Union, based in Piazza Porta San Donato 5, 40126 Bologna [Italy].

## Data Processing Location

The [Data] Processing related to the web services offered by this website takes place at the headquarters of the Data Controller and is carried out only by the Data Processors in charge.

No [Personal] Data deriving from the web service shall be disclosed [to any third party].

The Personal Data provided by Users who register online are used only for the purpose of using the service itself and for all the duties deriving from the management of the event and are not disclosed to any third parties, unless such disclosure is required by law or is strictly necessary for the fulfilment of regulatory obligations.

# [Personal] Data provided by Users

The [Personal] Data required by the IT procedure and entered by Users while filling in the webpages relating to the services provided are acquired and held on storage media of servers owned by the [Italian Mathematical] Union and are protected by security measures.

Failure to provide [Personal] Data by the Applicant might result in the impossibility to obtain the service requested.

## Data Processing Methods

Personal Data Processing is carried out by automated tools for the purposes for which they were collected. The [Personal] Data concerning registrations must be kept for an unlimited period of time, while the [Personal] Data relating to accounting management are kept for 3 years, and communications to Members must be kept for an unlimited period of time.

Specific security measures are adopted in order to prevent data loss, illegal or incorrect use and unauthorised access.

## Rights of Data Subjects

Data Subjects have the right at any time to obtain confirmation of whether this data exist and to know its content and origin, verify its accuracy or request its integration, updating or correction. They also have the right to request the cancellation, transformation into anonymous form or blocking of [Personal] Data processed in violation of the law, as well as to object in any case, for valid reasons, to their processing (Articles 15 to 22 of Regulation (EU) No. 679/2016).

The User, when participating to Conferences, Congresses, Seminars, Classes and other events organised by the [Italian Mathematical] Union, authorizes:

- the Italian Mathematical Union to take photographs and videos of him/her, to publish them for institutional purposes, without restrictions of time, place or medium or distribution channel, in whole, in part or in the form of individual frames including the parts that show his/her image, voice, name.
- the Italian Mathematical Union to publish on its institutional website and on its social networks.

However, the User does not authorize the use of his/her image in contexts that may prejudice his/her personal dignity and decorum and in any case for use and/or purposes other than those authorized hereinabove.

The User confirms that he/she will not be entitled to make any claim on the basis of the above and to irreversibly renounce all rights, actions, or claims arising from the authorizations hereinabove.

The User also declares to relieve the Italian Mathematical Union from strict liability (except in cases of wilful misconduct or gross negligence) for any damage caused to him/her, or by him/her to persons or things, due to negligence, recklessness, misbehaviour or accident.
